“Erasmus – Mobility for Studies (KA131/2021)”

Erasmus studies 2021/22 – grants assigned from KA131/2021 project

We would like to kindly inform you that the following groups of 2021/22 Erasmus outgoing students will receive funding from the Erasmus KA131/2021 project:

- students who declared ‘green travel’ (train, coach, car-pooling) after September 1st 2021
- students who declared starting mobility in October
- students nominated for the second semester
- students entitled to a UW social benefit (on the day of the nomination by the home department)
- students with a disability

Following monthly grant amounts, depending on the group of countries, will be applied:

- 520 EUR - Denmark, Finland, Ireland, Iceland, Liechtenstein, Luxembourg, Norway, Sweden;
- 500 EUR - Austria, Belgium, Cyprus, France, Greece, Spain, The Netherlands, Malta, Germany, Portugal, Italy;
- 450 EUR - Bulgaria, Croatia, Czech Republic, Estonia, Lithuania, Latvia, Rep. of North Macedonia, Romania, Serbia, Slovakia, Slovenia, Turkey, Hungary.

Students entitled to a **UW social benefit** and students with a **disability** will receive the following grants per month:

- 770 EUR - Denmark, Finland, Ireland, Iceland, Liechtenstein, Luxembourg, Norway, Sweden;
- 750 EUR - Austria, Belgium, Cyprus, France, Greece, Spain, The Netherlands, Malta, Germany, Portugal, Italy;
- 700 EUR - Bulgaria, Croatia, Czech Republic, Estonia, Lithuania, Latvia, Rep. of North Macedonia, Romania, Serbia, Slovakia, Slovenia, Turkey, Hungary.

All students are required to submit a scan of their **Student mobility form (Zgłoszenie kandydata na wyjazd)**. Please download the form from your USOSweb profile (*Student mobility > mobilities > view > Print form*), have it signed by the mobility coordinator and the Dean/ Head of the Didactic Unit. As it may be difficult to obtain both signatures during the holiday season, forms with one signature will be accepted (coordinator’s or Dean’s / Head of the Didactic Unit). The forms may be signed traditionally or with the use of a qualified electronic signature.

IRO is currently waiting for detailed information from the European Commission on the terms and conditions of the new Erasmus+ 2021 project. We will inform you as soon as possible about the requirements related to ‘green travel’ top-up as well as the possibility of signing the financial agreement.
