



IRO Announcement no 10/21/SMS/2021/2022

“Erasmus – Mobility for studies (KA131/2021)”

Financed from KA131/2021 project

Following the information received from the National Agency of the Erasmus+ Programme and the European Solidarity Corps, the terms and conditions of the Erasmus **KA131/2021** project, as well as the templates of individual agreements with beneficiaries will be published with a delay.

Consequently, we expect that students receiving the Erasmus grant from the **KA131/2021** project will be able to sign the financial agreements in the second half of September **at the earliest**, which means that the bank transfers will be made in the first half of October, **at the earliest**.

In view of this situation, students who are starting their studies at host universities in the first half of September and who have sufficient financial means to receive the grant with a delay, are kindly asked to wait until IRO announces the possibility to sign the agreements and publishes the terms and conditions of the new project (it will be possible to send us the agreement by post).

Students who are **starting their studies at host universities in the first half of September** and who cannot start their mobility without the grant are offered the following options:

- 1) Students, who have declared “**green travel**” (ecotravel) may receive the grant from the KA103/2020 project, provided they resign from the “green travel” top-up and do the language assessment test in the OLS system. Monthly grant rates are the same as in the KA131/2021 project:
 - a) **520 EUR** - Denmark, Finland, Ireland, Iceland, Liechtenstein, Luxembourg, Norway, Sweden;
 - b) **500 EUR** - Austria, Belgium, Cyprus, France, Greece, Spain, The Netherlands, Malta, Germany, Portugal, Italy;
 - c) **450 EUR** - Bulgaria, Croatia, Czech Republic, Estonia, Lithuania, Latvia, Rep. of North Macedonia, Romania, Serbia, Slovakia, Slovenia, Turkey, Hungary.

- 2) Students who are entitled to the **UW social benefit** may receive the grant from the KA103/POWER/2020 project, provided they resign from the “green travel” top-up and do the language assessment test in the OLS system. **The grant is paid out in PLN and the financial agreement must be signed before the mobility starts. Monthly grant rates applicable in this project include the social benefit top-up:**
 - a) **3069 PLN** - Denmark, Finland, Ireland, Iceland, Liechtenstein, Luxembourg, Norway, Sweden;
 - b) **2984 PLN** - Austria, Belgium, Cyprus, France, Greece, Spain, The Netherlands, Malta, Germany, Portugal, Italy;
 - c) **2771 PLN** - Bulgaria, Croatia, Czech Republic, Estonia, Lithuania, Latvia, Rep. of North Macedonia, Romania, Serbia, Slovakia, Slovenia, Turkey, Hungary.

d) **Students with a disability** may receive the grant from the KA103/POWER/2020 project for students with disabilities, provided they resign from the “green travel” top-up and do the language assessment test in the OLS system. **The grant is paid out in PLN and the financial agreement must be signed before the mobility starts (after the National Agency of the Erasmus Programme approves the student’s application for the additional funds).** The following monthly grant rates apply:

- a) **2217 PLN** - Denmark, Finland, Ireland, Iceland, Liechtenstein, Luxembourg, Norway, Sweden;
- b) **2131 PLN** - Austria, Belgium, Cyprus, France, Greece, Spain, The Netherlands, Malta, Germany, Portugal, Italy;
- c) **1918 PLN** - Bulgaria, Croatia, Czech Republic, Estonia, Lithuania, Latvia, Rep. of North Macedonia, Romania, Serbia, Slovakia, Slovenia, Turkey, Hungary.

Please note! In order to receive the grant from the KA103/POWER/2020 project for students with disabilities **it is mandatory to submit an application for additional funds.** In the application you may apply for funding in various categories. At least one category must be filled, ex. cost of travel to and from the host university. The application must be approved by the National Agency of the Erasmus Programme.

We would like to confirm that it is possible to postpone the mobility to the second semester or shorten a full-year mobility to just one semester (second semester) on condition that the home department and the host university agree to this change.

After signing the financial agreement it will not be possible to revert back to the KA131/21 funding so we kindly ask you to make an informed decision.
